***DEVELOPMENT OF COMMON TECHNOLOGY:
MULTILATERAL COOPERATION AMONG SCIENCE
AND BUSINESS COMMUNITIES OF THE TURKPA COUNTRIES***

Parliamentary Assembly:

Recognizing the high level of favorable economic relationships between the TURKPA member countries and recognizing that the member countries have particular importance in this area;

Highly appreciating the implementation and successful application of new technologies in the economies of the TURKPA member countries;

Noting the importance of the subject "prospects for innovation in the TURKPA member countries" considered at the 6-th meeting of the TURKPA Commission for Economic Cooperation, which was held on September 27, 2018 in Ankara;

Especially appreciating that the 6-th Summit of the Cooperation Council of Turkic-speaking States (CCTS), held on September 3, 2018 in Cholpon-Ata, was devoted to the subject "cooperation in the sphere of national sports and youth";

Highly appreciating the mutual cooperation of the scientists from the National Academies of Sciences of the TURKPA member countries and research centers of the leading universities in the member countries;

Noting the need for further improvement of the relationships in the field of science between the TURKPA member countries

Approving the United Nations Development Program (UNDP) project "from idea to entrepreneurship" for startup and youth business ideas support, implementation of innovations and new technologies;

Taking into account the need to continue improvement of the science and entrepreneurship combining processes for new technologies through the establishment of joint mechanisms and practices on the favorable and efficient basis that will be useful to all parties;

Noting the important role of scientific discoveries in the field of new technologies in the world economy development;

Using their practices of countries in the field of new technologies and experience in innovative inventions;

Noting the need for cooperation between the member countries in the field of new modern technologies applied in production;

Recommends the parliaments of the Member States:

- a) Creation of stimulating preferential tax system aimed at creating economically favorable conditions for enterprises in order to increase expenditures for scientific research and development works, introduction of new technologies in production;
- b) Advanced training of the engineering technical personnel of the member countries, as well as employees of the scientific research institutes in higher educational institutions;
- c) Consideration of legislation aimed at supporting entrepreneurs, in order to create conditions for primary activities of young entrepreneurs;
- d) Sharing experience and developing mutual cooperation between the institutes of the National Academy of Sciences of the member countries dealing with innovations, in order to discuss and analyze trends of new technologies in the world economy;
- e) Sending the members of the TURKPA commission for economic cooperation and relevant experts to the organized international economic thematic forums on development of high technologies in order to improve the legislative framework in the field of innovative production in the member countries;
- f) Organizing discussions between the employees of the state institutions dealing with investments and innovations, and experts of relevant departments of parliaments in order to improve the legislation of the member countries in the field of innovations;

g) Establishing relations between the agricultural committees of the parliaments of the TURKPA member countries, sharing experience in the field of new technological agricultural equipment;

h) All above-mentioned mechanisms must be considered within the framework of the general investment and innovation program and with the support of the TURKPA member countries.
